Taking Energy to the Streets ...

a Case for Natural Gas Vehicles

Natural Gas Vehicles (NGVs) are a proven and energy-efficient technology alternative for replacing gasoline- and diesel-powered vehicles. However, they have been slow to catch on due to limited public fueling infrastructure and capital costs associated with it. There is a lack of confidence that long-term fueling infrastructure will be available, resulting in a hesitancy among commercial entities to adopt NGVs into their fleets.

Meeting the Challenge

To help bridge this gap, NJNG has moved to expand New Jersey's compressed natural gas (CNG) fueling infrastructure with the goal of stimulating conversion of New Jersey fleets to NGVs while supporting the state's Energy Master Plan.

NJNG entered into host fleet agreements with Waste Management, Inc. in Toms River; Shore Point Distributing Company, Inc. in Freehold Township and the Township of Middletown, Department of Public Works, investing \$10 million to build the first public access CNG fueling stations in Monmouth and Ocean Counties. With completion expected in late fall 2014, NJNG will install, own and maintain the CNG fueling station infrastructures, with the host facility making them available for public use.

These public fueling stations increase accessibility to CNG in the state and provide CNG transportation options to area fleets. Moreover, they represent a great opportunity for local fleet operators to enjoy the financial and environmental rewards natural gas provides as a fuel without the upfront costs associated with building the necessary infrastructure. It also allows the host sites and local fleet operators to realize an accelerated payback on incremental costs of acquiring NGVs. This is particularly good news for local companies ready to begin the transition over to NGVs.

Taking Advantage of the Benefits

The primary driver for NGV fleet adoption exists in the cost differential between natural gas and conventional fuel. In addition, the use of NGVs help lower emissions and provide a viable and economically valuable alternative to traditional petroleum-based fuel. The many benefits of NGVs include:

- CNG can reduce fuel costs between 30 and 40 percent over petroleum-based fuels, including diesel. The lower cost of natural gas fuel means there is a short payback period before realizing significant savings over the lifecycle of the vehicle.
- Because natural gas burns cleaner, it helps keep a vehicle in optimal shape, which means reduced maintenance costs and a longer vehicle lifespan, among others.
- According to the American Gas Association, NGVs produce up to 30 percent fewer greenhouse gas emissions than diesel – benefitting the environment while decreasing our reliance on foreign resources.

Looking to the Immediate Future

The increasing CNG infrastructure available to commercial fleets, particularly those operating dedicated routes, opens the door for companies to consider the long-term advantages of NGVs – especially those that have customers interested in seeing them switch to a greener fuel.

Plan Before You Plant

The fall season is a great time for planting and landscaping. But where you plant your tree is important for the safety of you and others. You could damage not only a natural gas or other underground public utility line, but as a tree matures, its roots could entangle an underground utility line and, eventually, disrupt service to an entire neighborhood. This could result in fines and repair costs. More importantly, it can cause harm to you or those around you. Smart digging is no accident! So, drop that shovel and call 811 at least three business days prior to planting for a FREE markout of your underground public utility lines. In New Jersey, "It's the Law!"

Thinking about Purchasing a Natural Gas Generator?
