- I acknowledge and agree that I am solely responsible for visibly marking, with paint and flags, the existence and location of customer-owned underground facilities (including but not limited to, sprinklers, septic, oil tanks, electrical, sewer, water, etc.) within ten feet of the existing gas service line. Although reasonable precautions will be taken by NJNG when excavating, neither the Company nor its contractors shall be responsible for any damage to customer-owned facilities that are not marked (as described above). If applicant suspects that an underground facility is damaged, he or she shall notify the Company immediately.
- I acknowledge and agree that I will be responsible for paying any state, county or municipal road opening fee charged in connection with removal of the gas facilities.

If after the commencement of the work hazardous material is discovered at the worksite, NJNG shall be entitled to immediately stop work in the affected area. NJNG shall report the condition to me and to the appropriate government agency with jurisdiction. NJNG shall not be required to perform any work relating to or in the area of hazardous material without written mutual agreement.

I shall indemnify and defend NJNG at all times after the date of this agreement against any liability, loss, damages (including punitive damages), claim, settlement payment, cost and expense, interest, award, judgment, diminution in value, fine, fee, and penalty, or other charge, arising out of or relating to the retirement of the natural gas facilities, except to the extent caused by the negligent acts or omissions of NJNG. In the event of negligent acts or omissions by NJNG, I agree to limit my recovery to actual damages and to waive all claims against NJNG for any consequential damages.
