



NJNG E-TIPS 200K SUBSCRIBERS SWEEPSTAKES OFFICIAL RULES

Please read the Official Rules and Regulations (“Official Rules”) of the New Jersey Natural Gas E-Tips 200k Subscribers Sweepstakes (“Sweepstakes”). You must agree to accept and comply with the Official Rules to participate in the Sweepstakes.

November or December 2020 E-Tips issues. Please read the Official Rules and fully complete the online entry form, including your providing, at a minimum, Account Holder's name, NJNG Account Number and email address. Use the sweepstakes link to complete the entry profile and survey questions as directed to submit your entry. All entrants must have a valid email address.

In the event more than one (1) Entry is received from any one account number, the first Entry processed will be considered the only valid Entry received for the Sweepstakes Period. In the event of a dispute, Entries will be deemed made by the authorized account holder of the NJNG account number submitted at the time of Entry. The authorized account holder is the person who is assigned to the NJNG account number by NJNG. The potential winner may be required to show proof of being the authorized account holder. No mechanical reproductions permitted. Sponsor is not liable for lost, late, misdirected, or corrupted Entries whether due to a technical error or otherwise. Entries become the property of Sponsor and will not be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Sponsor.

SWEEPSTAKES WINNER SELECTION: Two hundred (200) Sweepstakes Prize Winners will be selected in a random drawing within a week of close of the Sweepstakes period. Drawing will be conducted by Sponsor at the Sponsor address. If a prize is refused, a prize notification is returned or deemed undeliverable, or the potential winner is disqualified for any reason, an alternate winner will be selected via a random drawing. Except where prohibited by law, acceptance of the prize constitutes permission for Sponsor to use winner's name, hometown, likeness, statements, and other personally identifiable information for promotional, advertising and marketing purposes in any media throughout the world without additional prize, incentive, consideration, consent or review. DISPUTES: Entrants agree that (a) any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved

individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of New Jersey; (b) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes but in no event attorneys' fees; and (c) under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to, claim punitive, incidental and consequential damages and any other damages, other than out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
