- Applicant must be a customer of one of the following electric utilities: Atlantic City Electric; Jersey Central Power & Light; PSE&G; Rockland Electric Company.
- Valid for ENERGY STAR qualified dehumidifiers purchased from May 14 through December 31, 2008.
- Completed rebate requests must be postmarked no later than January 31, 2009.
- Rebate request must be accompanied by proof of purchase (legible copy of dated sales receipt).
- Rebate request must include store name, manufacturer,
 ENERGY STAR model number, serial number and purchase price.
- Limit two rebates per utility customer for purchases under this program.
- Unit must be installed in New Jersey.
- Offer limited to new products only.
- All rebated products must be listed by the EPA as ENERGY STAR qualified.
- Rebates are subject to available funds.
