Important Notes:

The BGSS ("Price to Compare") and Rate Credit are applicable to Residential Service (RS) sales customers and General Service Small (GSS) sales customers.

The BGSS ("Price to Compare") and Rate Credit are not applicable to RS and GSS transportation customers who purchase natural gas commodity from a third party supplier at prices provided by the third party supplier.

From November 1, 2016 through December 31, 2016, RS and GSS sales customers receive a BGSS rate credit of \$0.1666 per therm.

From January 1, 2017 through February 28, 2017, RS and GSS sales customers receive a BGSS rate credit of \$0.1664 per therm.

Tables include all taxes and exclude any one time credit.

For those months when rates change mid-month, rates shown in the tables are prorated based on the number of days in effect.
