All entries will be posted to New Jersey Natural Gas' Facebook timeline and may be shared in NJNG's Facebook photo albums. All entry information shall be collectively referred to herein as the "Entries" or each as an "Entry." Entries must comply with the Guidelines and Restrictions defined below.

If you chose to enter via Facebook, you must be a registered user of Facebook and comply with the Terms of Service found at https://www.facebook.com/terms.php in order to enter the Sweepstakes. All terms and conditions of Facebook.com apply. To the extent of any conflict between these Official Rules and the Facebook Terms of Service, these Official Rules will apply.

Limit (1) one Entry per firehouse regardless of the method of entry. Entrants are not permitted to submit an Entry more than once during the Sweepstakes Period. Duplicate Entries by the same firehouse will be subject to disqualification. Multiple entrants are not permitted to share the same email account. Any attempt by any Entrant to obtain more than the stated number of Entries by using multiple/different email accounts, identities, registrations and logins, or any other methods will void that Entrant's Entries and that Entrant may be disqualified.

No automated entry devices and/or programs permitted.
